LOCAL RESTRICTION TIERS: WHAT YOU NEED TO KNOW

From 2 December New Forest District Council will be in **Tier 2: High Alert**.

This is for areas with a higher or rapidly rising level of infections, where some additional restrictions need to be in place.

In tier 2:

- you must not socialise with anyone you do not live with or who is not in your support bubble in any indoor setting, whether at home or in a public place
- you must not socialise in a group of more than 6 people outside, including in a garden or a public space – this is called the ‘rule of 6’
- businesses and venues can continue to operate, in a [COVID-Secure](#) manner, other than those which remain closed by law, such as nightclubs
- pubs and bars must close, unless operating as restaurants. Hospitality venues can only serve alcohol with substantial meals
- hospitality businesses selling food or drink for consumption on their premises are required to:
 - provide table service only, in premises which sell alcohol
 - close between 11pm and 5am (hospitality venues in airports, ports, transport services and motorway service areas are exempt)
 - stop taking orders after 10pm
- hospitality businesses and venues selling food and drink for consumption off the premises can continue to do so after 10pm as long as this is through delivery service, click-and-collect or drive-through
- early closure (11pm) applies to casinos, cinemas, theatres, museums, bowling alleys, amusement arcades, funfairs, theme parks, adventure parks and activities, and bingo halls. Cinemas, theatres, and concert halls can stay open beyond 11pm in order to conclude performances that start before 10pm
- public attendance at outdoor and indoor events (performances and shows) is permitted, limited to whichever is lower: 50% capacity, or either 2,000 people outdoors or 1,000 people indoors
- public attendance at spectator sport and business events can resume inside and outside, subject to [social contact rules](#) and limited to whichever is lower: 50% capacity, or either 2,000 people outdoors or 1,000 people indoors
- places of worship remain open, but you must not socialise with people from outside of your household or support bubble while you are indoors there, unless a legal exemption applies
- weddings and funerals can go ahead with restrictions on numbers of attendees – 15 people can attend wedding ceremonies and receptions, 30 people can attend funeral ceremonies, and 15 people can attend linked commemorative events such as wakes or stone settings.
- organised outdoor sport, and physical activity and exercise classes can continue
- organised indoor sport, physical activity and exercise classes will only be permitted if it is possible for people to avoid mixing with people they do not live with (or share a support bubble with).

There are exceptions for indoor disability sport, sport for educational purposes and supervised sport and physical activity for under-18s, which can take place with larger groups mixing

- you can continue to travel to venues or amenities which are open, but should aim to reduce the number of journeys you make where possible
- if you live in a tier 2 area, you must continue to follow tier 2 rules when you travel to a tier 1 area. Avoid travel to or overnight stays in tier 3 areas other than where necessary, such as for work, education, youth services, to receive medical treatment, or because of caring responsibilities. You can travel through a tier 3 area as a part of a longer journey

A MESSAGE FROM ASSISTANT CHIEF CONSTABLE MAGGIE BLYTH

Limiting the spread of the virus is primarily the responsibility of public health, but we know that our role is an important one and that compliance with Government legislation will be an influencing factor in mitigating risks

for the public and the NHS at this important time.

Assistant Chief Constable, Maggie Blyth, said: "Whilst Engaging, Explaining and Encouraging people to comply will remain a focus as officers react to the circumstances they are presented with, enforcement for blatant breaches is necessary.

"We know lots of people are weary of the changes to the rules, and recognise the impact of the pandemic on people's livelihoods and the impact of these further measures. As part of our response we will work closely with partners and communities over the coming days and weeks. The support we continue to give to the public of Hampshire and the Isle of Wight remains vital.

"To the vast majority who have complied with restrictions throughout this year. I'd like to, again, say thank you and urge you to please carry on doing so to ensure that we do not lose the momentum and shared purpose that we have had so far. To the minority who feel that the restrictions do not apply to them, including those organising large gatherings and deliberately holding parties or events that put people at risk, please be aware that we are increasing our levels of enforcement in line with the threat that we are facing to people living in our communities, and to our NHS.

"We won't waste time with endless encouragement for those who knowingly or deliberately break the rules. People recklessly ignoring the regulations should expect to receive a fixed penalty notice. It is only right that those who are putting others at risk should face consequences.

"I would also urge people to please refrain from calling us to ask questions about the new legislation, we need to keep our lines open for emergency calls.

"Thank you for your ongoing commitment. Hampshire Constabulary remains committed to playing its part keeping you and our communities safe in these unprecedented times".

CV19 TESTING SITES

More testing sites are opening across Hampshire, making it easier and more convenient for local people to access testing for coronavirus. These are **appointment-only**, walk-through sites and will help ensure access to prompt testing, particularly for those who are unable to access

NEW GRANT TO SUPPORT BUSINESSES IMPACTED BY NATIONAL CV19 RESTRICTIONS

A new fund to support local businesses impacted by national coronavirus restrictions is now open for applications.

New Forest District Council are making one-off discretionary grant payments to support the fixed property costs of specific types of business, that are impacted (but not necessarily closed) by the National Restrictions for the period 5 November – 2 December 2020.

The fund is called the **Additional Restrictions (Discretionary) Grant**.

The fund, which will make payments of up to £3,000 per business, is specifically aimed at businesses not previously eligible for the Local Restrictions Support Grant (LRSG) and are impacted (but not necessarily closed) by the national restrictions.

The level of grant awarded will be based upon annual fixed premises costs for the business and all businesses applying will need to be able demonstrate these at the point of application. Home-based businesses will be eligible providing they meet the criteria of the fund.

Key business types will be prioritised in this fund. These are businesses in the retail, hospitality, events and leisure sectors, businesses in the immediate supply chain for those sectors, and business required to close by law, but which do not pay business rates (and are therefore not eligible for the Local Restrictions Support Grants (LRSG)).

New Forest District Council's Portfolio Holder for Economic Development Cllr Michael Harris OBE said;

"This grant will provide vitally important support for businesses which have already experienced considerable hardship. The fund will help to retain local jobs and supply chains at a time of year which is so critical to many businesses in the New Forest economy."

Applications can be made on the New Forest District Council website <https://www.newforest.gov.uk/article/1274/Financial-support-for-businesses-affected-by-coronavirus> and will remain open until **12pm on Friday 29 January 2021**.

This scheme is subject to limited funding and will be closed as soon as funds have been exhausted.

LICENSED FIREARM SECURITY

At the beginning of November, we received three reports of thefts of shotguns. In two of these, guns had not been properly secured and, along with ammunition.

While shotguns and firearms are every day equipment for some of our certificate holders, it is really important that the highest level of security is maintained, and guns should not be left unattended out of their cabinets for any period of time.

We all have a duty of care to ensure that it is made as difficult as possible for guns to fall into the wrong hands.

Certificate holders will be aware that they have a lawful duty to maintain security of their guns at all times, and they should know that, in addition to being dealt with for any criminal offences arising from a breach of security, certificates will invariably be revoked.

Please work with us to prevent these thefts and serious harm by reporting anything you think we should know, either through online reporting via our website www.hampshire.police.uk, by calling 101, or ringing Crimestoppers (0800 555 111) anonymously. In an emergency, if something is happening there and then, ALWAYS dial 999.

We are also seeing a series of thefts of quad bikes, farming equipment, power tools etc from rural outbuildings. Please make these items and buildings as secure as possible and if you see anything suspicious happening, report it immediately.

SPATE OF BURGLARIES

We are warning residents to be on their guard following a number of burglaries across the New Forest, specifically those living in the Ringwood area.

This comes after eight burglaries were reported over the weekend of 5-9 November.

The burglaries happened at various times throughout this period, largely affecting residential properties, but there were also instances of commercial properties being targeted. It was mostly power tools and other small items that were stolen and as part of this, we are investigating:

- A burglary at Burley Lodge stables between 6pm on Thursday 5 November and 10am on Friday 6 November (Crime ref: 44200432945)
- A burglary at an address on Lyndhurst Road between 12am and 3am on Friday 6 November (Crime ref: 44200431238)
- A burglary at an address on Lyndhurst Road between 6pm on Thursday 5 November and 8.30am on Friday 6 November (Crime ref: 44200430551)
- A burglary at an address on Burley Road, Bransgore between 6pm on Saturday 7 November and 10am on Sunday 8 November (Crime ref: 44200433192)
- A burglary at a number of garages at Burgate Court on Salisbury Road between 10pm and 11.15pm on Friday 6 November (Crime ref: 44200432035)
- A burglary at a number of garages at Renoir Burgate Court on Salisbury Road between 10.15pm and 11pm on Friday 6 November (Crime ref: 44200431711)
- A burglary at an address on Gorley Road at around 8.40pm on Thursday 5 November (Crime ref: 44200431165)
- A burglary at an address on Green Lane at around 1.30am on Friday 6 November (Crime ref: 44200430622)

While three commercial properties were also targeted, and as such we are investigating;

- A burglary at the London Tavern on Linford Road between 9.30pm on Saturday 7 November and 7.50am on Sunday 8 November (Crime ref: 44200433028)
- A burglary at the Railway Hotel on Hightown Road between 11.30 and 11.30pm on Saturday 7 November (Crime ref: 44200432827)
- A burglary at a Sainsbury's branch on Meeting House Lane between 12.10am and 12.25am on Sunday 8 November (Crime ref: 44200432862)

We would like to hear from anyone with information on any of these incidents. Did you notice anything suspicious? Perhaps you saw someone hanging around the area? Anyone with information can phone 101, quoting the crime reference numbers above.

We also wanted to take the opportunity to remind you of our crime prevention advice

around burglaries:

- Lock your shed or garage every evening, ensuring that you have a reliable and robust lock in place to deter any would-be burglars
- Mark your prized possessions by using a property or police approved forensic marking solution only visible under Ultraviolet light
- Ensure side gates are locked to prevent access to the rear of the property.
- Record the details of your property such as serial numbers for electronic goods on the Immobilise website (<https://www.immobilise.com/>)
- You know your local communities. If you notice anything out of the ordinary, such as someone tampering with a lock on a neighbour's shed, please report it to us via 101.

CAUTION URGED DURING THE DEADLIEST MONTHS FOR THE NEW FOREST ANIMAL ACCIDENTS

Drivers using New Forest roads are reminded that animal accidents increase in the lead up to Christmas.

Commuters are urged to be vigilant as accidents involving animals in the Forest peak between 5pm and 8pm on weekdays in the winter months.

They are also being encouraged to slow down from 40mph to 30mph, a move which adds only three extra minutes to most journeys across the Forest and can drastically reduce accidents involving animals.

How drivers can help:

- Be ready to stop – animals can step out even when they've seen you approaching.
- Drive slowly, especially at night – there is a pool of darkness behind the headlights of approaching cars - an animal may be standing in it.
- Give animals grazing by the side of the road a wide berth – cross to the other side of the road and be prepared to STOP if there is on-coming traffic.
- Grazing animals on both sides of the road? Take extra care – they may cross to join their friends.
- One animal by the roadside means there are others close by – be aware.
- Bends and tops of hills need more care – animals may be standing in the road just out of sight.
- Reflective collars worn by some ponies may help you see them in the dark - but be aware that not all ponies have them.
- Deer can easily jump the fences alongside roads like the A337, A31 and A35 – and when there is one deer more will usually follow.

Be animal aware at all times.
