046.14 **Apologies** – Apologies had been received and were accepted from SueBennison, Kay Harrison, Cllr Edward Heron, Cllr Diane Andrews and PC Rob Morant.

047.14 **Disclosures of interest.** No disclosures made.

048.14 **Minutes** – The Council agreed the agreed that the minutes of 25<sup>th</sup> March 2014 were a true record of that meeting.

DJ expressed his concern that Natural England appeared to be able to hold up the installation of a new BT box on Brook Green; also that no comments appeared to have been submitted by Bramshaw Parish Council – clerk to look into why council's response not on NPA website and to take up with planning department Natural England's comments as there was a real need for faster broadband not to be delayed.

DJ also was concerned that the agendas were not sufficiently detailed with particular reference to the Bramble Hill appeal – to be discussed under planning..

### Councillors' reports

Ian Davies outlined the incident that happened at Stocks Cross as a result of some enthusiastic marshalling during the recent Wiggle Event .

A resident had contacted Denis Shaughnessey expressing their concern over a smelly bonfire at Barford/Dazel which had resulted in them having to keep their windows shut – DS outlined how he had in the past managed to get funding from the EU to collect the agricultural waste (silage wrapping etc) from the commoners. Council asked clerk to write a letter to the farmer reminding him that it is illegal under the Clean Air Act to have a bonfire that produces dark or black smoke or other harmful

combustible products. Clerk also to put reminder in Forest Views, Bramshaw Telegraph and on the web site.
