031.15 **Apologies** – to agree any absences of councillors. Apologies were received and accepted from Ian Davies, Jenny Watts and NFDC Cllr Diane Andrews.

032.15 **Disclosures of interest**.

033.15 **Minutes** – to agree the minutes of 24th February 2015 as a true record.

Kay Harrison asked for the point in Dylan Everett's report that the cattle would be turned out on 9th April 2015 to be removed, as she did not feel this was an accurate comment. The chairman struck through this comment in the minutes and duly signed them as being an accurate record of the meeting.

County Cllr Edward Heron

Traffic calming – it was clear from the consultation that there was an overwhelming interest in something being done – Edward has a meeting with the leader of the County Council to see how this can be taken forward – but in his view, Bramshaw needs 'aggressive traffic calming' so that at peak times vehicles are physically slowed down and inconvenienced by the measures, with the result that they will stop using the road as a rat run. Edward believes that once it is designed, it will be built – some funds will be required from the parish towards the design. Edward also agreed to attend the Annual Assembly on May 19th.

<u>Kay Harrison</u> – expressed concern about lack visibility particularly in a tractor at the end of Vice Lane, and with the overhanging trees and also along Morgans Vale – clerk to write to Rob Millar, and Edward Heron.

<u>Sue Bennison –</u> there had been a NF Consultative Panel meeting on 12 March 2015 – Cllr Keith Mann had given a presentation on Local Enterprise Partnerships and how the NFNPA were looking forward to seeing how working closely with LEPs can benefit the Forest moving forward. SB had also spoken to Bruce Rothnie (FC) with regards to the litter along the B3079.

Meeting asked clerk to write to McDonalds at Ower to consider making a contribution towards the lengthsman's fund so we could ask him to pick up the litter on a more regular basis along B3079.
