9/18 Reports to be received

i) NFDC Cllr Diane Andrews

1. The Crime and Disorder Act 1998 requires the District Council to have a crime and disorder committee whose functions are to review decisions made or acts taken by "responsible authorities". The Crime and Disorder committee is known as Safer New Forest Strategy and Delivery group.

I chaired this group with the responsible Authorities attending which are:

Probation Services
Police
Fire and Rescue
Clinical Commissioning Group

They are assisted by other partners as and when required. E.g. Adult Services.

The committee prepare an annual strategy to target areas of crime that are felt to be important in the local area. This is in addition to the usual day to day work carried out by the Authorities.

Four areas have been identified Children at Risk, Modern Slavery & Human Trafficking, Drug Related Harm and Domestic Abuse.

2. The decision to allow Speed Watch to monitor roads in a 40mph area has still not been made. At the moment they are still restricted to 30mph. This is for the safety of the volunteers.

A new speed "gun" will be available in the near future and it is being calibrated at this time. I understand it is for use by Speed Watch.

ii) Bramshaw Parish Councillor reports

SD - Has reported footpath 4, Harley Lane to Ryan's farm, and footpath 3. Has received confirmation that footpath 4 has been cleared.

SB asked if the council has a map of the footpaths in the parish. **SD** confirmed that the Council did hold relevant parts of the Hampshire County Council definitive map. However, as footpaths lead, **SD** prefers to refer to the ordnance survey map, which is clearer and easier to read.

SD drew Members' attention to the New Forest National Park Submission Draft Local Plan 2016 – 2036 consultation which runs from Wednesday 17 January to 5pm on Wednesday 28 February 2018. This will be placed
